

A RESOLUTION RATIFYING THE SIGNATURE OF THE COUNTY ADMINISTRATOR ON THE LETTER OF UNDERSTANDING FROM SAINT JOSEPH MERCY HEALTH SYSTEM TO PROVIDE SUPPORT TO THE HEALTH DEPARTMENT FOR THE ONGOING OPERATIONS OF THE PRESCRIPTION FOR HEALTH PROGRAM IN THE AMOUNT OF \$160,000 FOR THE PERIOD OF MARCH 1, 2019 THROUGH FEBRUARY 29, 2020; AMENDING THE BUDGET; AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS

WHEREAS, Saint Joseph Mercy Health System seeks to provide support to the Prescription for Health program, shown to be an effective program to reduce food insecurity and improve fruit and vegetable consumption among participants; and

WHEREAS, local health data point to a need to increase access to fresh fruits and vegetables among food insecure individuals with chronic disease risk by connecting them to local sources of healthy food and support; and

WHEREAS, Washtenaw County Health Department will coordinate the Prescription for Health program in partnership with clinics, partners and farmers markets in the Ypsilanti, Chelsea and Milan areas to build capacity of provider organizations to connect participants, especially those who may need extra support, to local sources of healthy food; and

WHEREAS, the collaboration will work toward increasing participant knowledge and understanding of healthy eating and its relationship to chronic disease prevention and management; and

WHEREAS, this matter has been reviewed by Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby ratifies the Letter of Understanding to Saint Joseph Mercy Health System in the amount of \$160,000, for the period of March 1, 2019 through February 29, 2020 as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners takes the following actions contingent upon the receipt of the grant award in conformity with the grant application:

1. Authorizing the Administrator to sign the Memorandum of Understanding

2. Amending the budget, as attached hereto and made a part hereof
3. Authorizing the Administrator to sign delegate contracts in conformity with the application/award upon review of Corporation Counsel, to be filed with the County Clerk.
