

A RESOLUTION AUTHORIZING THE SIGNATURE OF THE COUNTY ADMINISTRATOR ON THE CONTRACT BETWEEN THE STATE OF MICHIGAN DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS AND WASHTENAW COUNTY HEALTH DEPARTMENT ON THE MICHIGAN MEDICAL MARIHUANA OPERATION AND OVERSIGHT PROJECT IN THE GRANT BUDGET AMOUNT OF \$130,377 (\$124,558 LARA / \$5,819 WCHD) FOR THE PERIOD OF JANUARY 1, 2019 THROUGH SEPTEMBER 15, 2019; AMENDING THE BUDGET; AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS; AND APPROVING THE CREATION OF GRANT STATUS POSITIONS.

WHEREAS, Washtenaw County Health Department has been actively involved in community health promotion efforts and health education messaging to effectively promote and protect public health; and

WHEREAS, the Washtenaw County Health Department has been awarded a grant by the State of Michigan Department of Licensing and Regulatory Affairs to increase the level of knowledge related to the laws and regulations surrounding medical marihuana and the rights and responsibilities of patients and caregivers; and

WHEREAS, this project promises to reduce potential risk associated with medical marihuana by understanding the importance of safe storage and driving precautions; and

WHEREAS, the project includes collaboration with public health, public safety and substance use disorder organizations; and

WHEREAS, the project will allow Washtenaw County Health Department to develop and disseminate medical marihuana educational materials and resources, and share messaging to reach targeted audiences in Washtenaw County; and

WHEREAS, this matter has been reviewed by Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby authorize the Contract with the State of Michigan Department of Licensing and Regulatory Affairs in the amount of \$124,558 for the period of January 1, 2019 through September 15, 2019 as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners takes the following actions contingent upon the receipt of the grant award in conformity with the grant application:

1. Authorizing the Administrator to sign the Contract
2. Amending the budget, as attached hereto and made a part hereof
3. Authorizing the Administrator to sign delegate contracts in conformity with the application/award upon review of Corporation Counsel, to be filed with the County Clerk.
