

A RESOLUTION AUTHORIZING THE SIGNATURE OF THE COUNTY ADMINISTRATOR ON THE CONTRACT BETWEEN THE MICHIGAN HEALTH ENDOWMENT FUND AND WASHTENAW COUNTY HEALTH DEPARTMENT ON THE HEALTHYONE PROJECT IN THE GRANT BUDGET AMOUNT OF \$139,140 (\$100,000 MHEF / \$39,140 STATE) FOR THE PERIOD OF MAY 1, 2019 THROUGH APRIL 30, 2021; AMENDING THE BUDGET; AUTHORIZING THE ADMINISTRATOR TO SIGN DELEGATE CONTRACTS; AND APPROVING THE CREATION OF GRANT STATUS POSITIONS.

WHEREAS, Washtenaw County Health Department has been actively involved in community health promotion and community engagement efforts to address health inequities; and

WHEREAS, the Washtenaw County Health Department has been awarded a grant by the Michigan Health Endowment Fund to address infant mortality, behavioral health, access to healthy food and health-related transportation with a focus on neighborhoods in Superior Township; and

WHEREAS, this project seeks to increase utilization of Washtenaw County Health Department services, availability of peer support and education, improve access to prenatal care and other health and social services, and increase insurance and benefit enrollment assistance; and

WHEREAS, the project includes collaboration with neighborhood, public health, housing, and children's service organizations; and

WHEREAS, the project will allow Washtenaw County Health Department to implement a community health worker model for a neighborhood tailored approach to lessen the stressors of poor living conditions and increase access to care for women, infants and their families; and

WHEREAS, this matter has been reviewed by Corporation Counsel, the Finance Department, Human Resources, the County Administrator's Office, and the Ways and Means Committee.

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners hereby authorize the Contract with the Michigan Health Endowment Fund in the amount of \$100,000 for the period of May 1, 2019 through April 30, 2021 as on file with the County Clerk.

BE IT FURTHER RESOLVED that the Washtenaw County Board of Commissioners takes the following actions contingent upon the receipt of the grant award in conformity with the grant application:

1. Authorizing the Administrator to sign the Contract
2. Amending the budget, as attached hereto and made a part hereof
3. Authorizing the Administrator to sign delegate contracts in conformity with the application/award upon review of Corporation Counsel, to be filed with the County Clerk.
