## HOW TO CALCULATE TAXES OWED FROM MILLAGE RATES.

1 MILL = \$.001    or    1 MILL = \$1 PER \$1000 TAXABLE VALUE

EXAMPLE: IF YOUR TAXABLE VALUE IS \$100,000

Your home is located in the City of Ann Arbor with a millage rate of 16.5658  
This millage is ONLY the City portion. Use this example to compute any millage.

FORMULA:    
$$\frac{\text{TAXABLE VALUE}}{1,000} \times \text{MILLAGE RATE}$$

$$\frac{100,000}{1,000} \times 16.5658$$

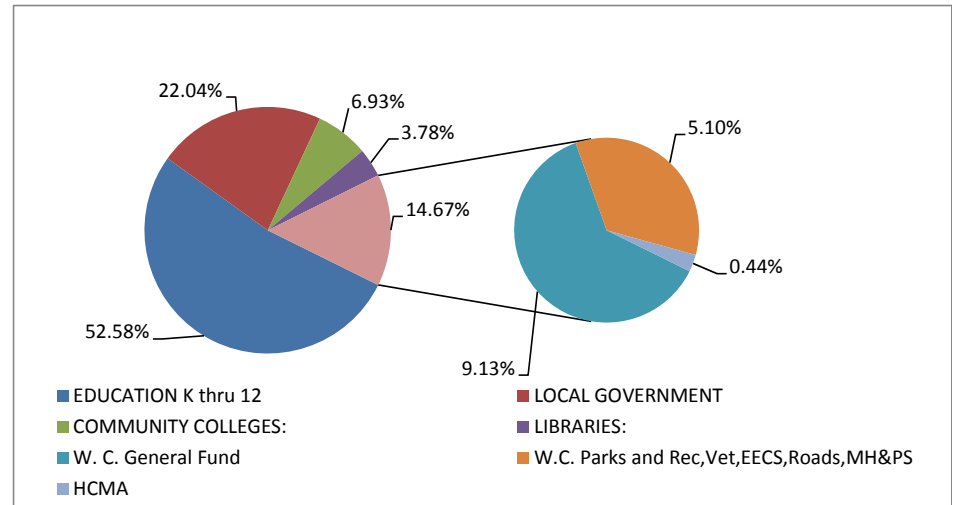
