Bond Proposal - Multi-Purpose Family Recreational Complex Bonding Proposition Shall the Charter Township of Ypsilanti, County of Washtenaw, Michigan, borrow the principal sum of not to exceed Twenty-Seven Million Nine Hundred Seventy-Five Thousand Dollars (\$27,975,000) and issue its general obligation unlimited tax bonds therefor in one or more series, payable in not to exceed twenty-five (25) years from the date of issuance, for the purpose of paying the cost of acquiring, constructing, furnishing and equipping a new Multi-Purpose Family Township Recreational Complex together with necessary site, utility and parking improvements and all appurtenances and attachments therefor?
