<b>PROPOSAL 1</b>				
Charter Township of Augusta Tax-Rate Limitation and Levy Proposal				
(Fire Protection and Prevention)				
Shall the limitation on the total amount of general ad valorem taxes which may be assessed in any one year upon real and tangible personal property in the Charter Township of Augusta, Washtenaw County, Michigan, be increased as provided by Section 6 of Article IX of the constitution of Michigan, 1963, by an amount equal to 3/4 of a mill (.75 cents per \$1,000.00) of the taxable value for a period of five (5) years from 2001-2006 inclusive, and shall the levy of such tax be authorized, for the purpose of providing revenue for fire protection and prevention, which increase will raise the first year of such levy an estimated \$94,480.50.

(Police Protection)				
Shall the limitation on the total amount of general ad valorem taxes which may be assessed in any one year upon real and tangible personal property in the Charter Township of Augusta, Washtenaw County, Michigan, be increased as provided by Section 6 of Article IX of the constitution of Michigan, 1963, by an amount equal to 1/2 of a mill (.50 cents per \$1,000.00) of the taxable value for a period of five (5) years from 2001-2006 inclusive, and shall the levy of such a tax be authorized, for the purpose of providing revenue for police protection, which increase will raise the first year of such a levy an estimated \$62,987.00
