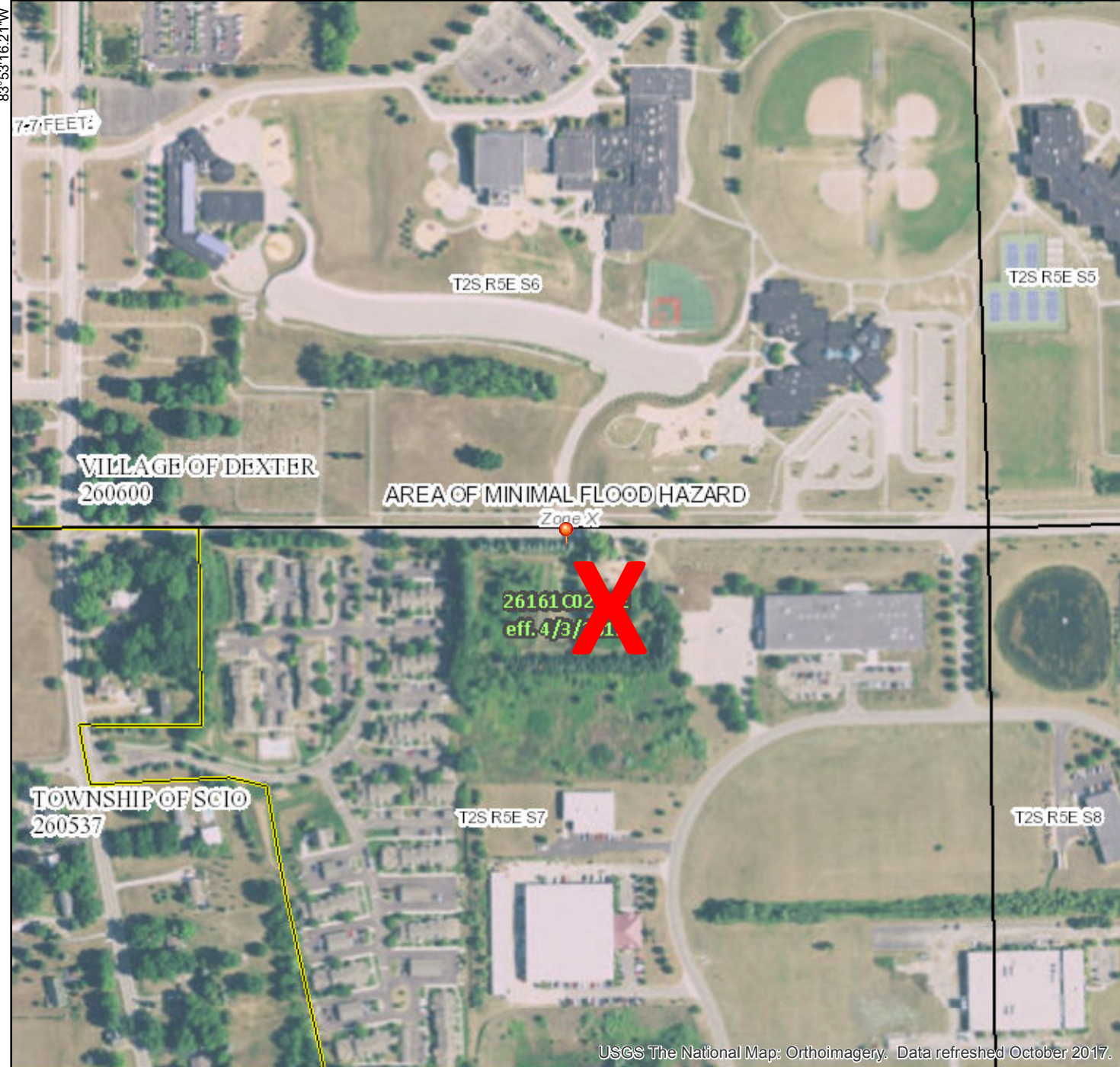
**Hilltop View Apartments Floodplain Management Narrative:**

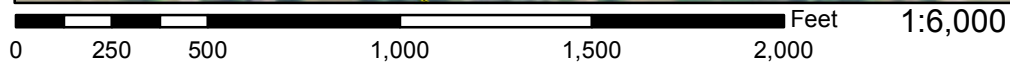
