NEW BUSINESS

a. Deliberations toward 2022 Washtenaw County Apportionment Plan

Chair Kestenbaum acknowledged the reading of statute provided by Dirk Mayhew. He stated that case law exists that allows county Apportionment Commissions to determine the number of districts and then draw boundaries that follow statutory criteria as much as possible while balancing district populations. He said that the statutory criteria for district boundaries should not be interpreted to dictate the number of districts that must be in the plan.

Commissioner McClary provided information about the costs associated with Board of Commissioners members and regarding the Board meeting room.

Vice Chair Frey spoke in favor of a 15-district apportionment plan.

Commissioner Savit stated that the statutory criteria for district boundaries cannot dictate the number of districts in the apportionment plan. He continued that the Apportionment Commission can determine the number of districts and then draw boundaries that follow statutory criteria as much as possible while balancing district populations.

Chair Kestenbaum stated the Apportionment Commission is getting close to adopting a final apportionment plan.
