-Ballot Question Committees-**

A Ballot Question Committee must submit the following statements in 2022 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline.

**2021 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED**

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2020 Annual Statement is required to be filed by all committees EXCEPT those committees that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2020.

File the following statements. If your committee supports or opposes a ballot proposal on a 2022 ballot, it must file a pre- and post- election statement in accordance with the election date listed below in lieu of a quarterly statement.

*April, July, and October are waived if the overlapping Pre and Post-Election CS are filed. October Statements are NOT owed in even years*

**May 3, 2022 Election:**

Pre-Election	April 17, 2022	April 22, 2022
Post-Election	May 23, 2022	June 2, 2022

**\*\*Late Contribution Reports Period from: April 18-April 30, due 48 hours after receipt.**

**August 2, 2022 Election:**

Pre-Election	July 17, 2022	July 22, 2022
Post-Election	August 22, 2022	September 1, 2022

**\*\*Late Contribution Reports Period from: July 18-July 30, due 48 hours after receipt.**

**November 8, 2022 Election:**

Pre-Election	October 23, 2022	October 28, 2022
Post-Election	November 28, 2022	December 8, 2022

**\*\*Late Contribution Reports Period from: October 24-November 5, due 48 hours after receipt.**

**\*\* Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15<sup>th</sup> to 3<sup>rd</sup> day prior to election. They are NOT waived by the reporting waiver.**
