

A RESOLUTION APPROVING AND ADOPTING THE WASHTENAW COUNTY PUBLIC HEALTH DIVISION COMMUNITY RIGHT-TO-KNOW REGULATION GOVERNING THE IDENTIFICATION AND DISCLOSURE OF TOXIC AND HAZARDOUS SUBSTANCES, AS AMENDED

WASHTENAW COUNTY BOARD OF COMMISSIONERS

February 21, 1990

WHEREAS, the Washtenaw County Board of Commissioners approved and adopted the Washtenaw County Health Department Community Right-to-Know Regulation of 1986 (the "Regulation") during its April 2, 1986 meeting and approved and adopted amendments to "the Regulation" on April 1, 1987; and

WHEREAS, the Public Health Division developed amendments to the Regulation, reflecting certain technical amendments and substantive changes resulting from consultations with regulated and interested parties; and

WHEREAS, the Washtenaw County Board of Commissioners and the Washtenaw County Public Health Division held a joint public hearing on January 17, 1990 to receive input from citizens regarding the proposed amended Regulation ("Amended Regulation"); and

WHEREAS, the Washtenaw County Public Health Advisory Committee adopted the Amended Regulation during its February 2, 1990 meeting, subject to approval by the Washtenaw County Board of Commissioners with the condition that the Committee that worked to develop the amendments work with the Public Health Advisory Committee and the Health Officer to spell out criteria regarding civil penalties; and

WHEREAS, this has been reviewed by the County Administrator, Controller, Corporation Counsel, and the Ways & Means Committee

NOW THEREFORE BE IT RESOLVED that the Washtenaw County Board of Commissioners approves the Public Health Advisory Committee's adoption of the Amended Regulation to become effective March 1, 1990, a copy of which is attached hereto, and approves the Amended Regulation, as written.
