ON 8/17 @ 11/5, KIRK WESTPHAL VOTED TO HAVE A DEER "CULL" KILLING, THAT IS NOT SUPPORTED BY SCIENTIFIC EVIDENCE TO CONTROL DEER POPULATION, AND WOULD CREATE AN UNJUSTIFIABLE DANGER TO PUBLIC SAFETY, BECAUSE THE KILLING WOULD BE DONE WITHIN THE CITY OF ANN ARBOR, WITH HIGH POWERED RIFLES, AT NIGHT, ON PUBLIC PROPERTY.


