


## HOW TO SEARCH THE COURT CALENDAR FOR FUTURE HEARINGS

3. If you are an attorney and you want to see all of your future hearings, select to search by **Attorney**. From there, you can either search by name or bar number. It is recommended that you change the second date of the date range to one year out by simply replacing the last number by one additional number (i.e. in year 2016, just change the 6 to a 7). Then click on the **Search** button. This will show you all hearings scheduled for the next full year.
