-Ballot Question Committees-**

A Ballot Question Committee must submit the following statements in 2020 unless it is eligible for and requests a reporting waiver prior to the close of the books for the applicable filing deadline.

2019 ANNUAL CAMPAIGN FINANCE STATEMENT REQUIRED

Public Act 119 of 2017 has reinstated the annual reporting requirement. A 2019 Annual Statement is required to be filed by all committees EXCEPT those committees that maintain a reporting waiver or file a Post-Election Campaign Finance Statement in December, 2019.

File the following statements. If your committee supports or opposes a ballot proposal on a 2020 ballot, it must file a pre- and post- election statement in accordance with the election date listed below in lieu of a quarterly statement.

July Statement	July 20, 2020	July 27, 2020
2020 Annual Statement	December 31, 2020	January 31, 2021

April, July, and October are waived if the overlapping Pre and Post-Election CS are filed. October Statements are NOT owed in even years

March 10, 2020 Election:

Pre-Election	February 23, 2020	February 28, 2020
Post-Election	March 30, 2020	April 9, 2020

***Late Contribution Reports Period from: February 24-March 7, due 48 hours after receipt.*

May 5, 2020 Election:

Pre-Election	April 19, 2020	April 24, 2020
Post-Election	May 25, 2020	June 4, 2020

***Late Contribution Reports Period from: April 20-May 2, due 48 hours after receipt.*

August 4, 2020 Election:

Pre-Election	July 19, 2020	July 24, 2020
Post-Election	August 24, 2020	September 3, 2020

***Late Contribution Reports Period from: July 20-August 1, due 48 hours after receipt.*

November 3, 2020 Election:

Pre-Election	October 18, 2020	October 23, 2020
Post-Election	November 23, 2020	December 3, 2020

***Late Contribution Reports Period from: October 19-October 31, due 48 hours after receipt.*

**** Late contribution reports are required when \$2,500 or more is contributed by a single contributor during 15th to 3rd day prior to election. They are NOT waived by the reporting waiver.**
