



Precinct Delegate Positions – August State Primary Only

Candidates elected to precinct delegate positions are certified to the county clerk by the board of ELECTION INSPECTORS at each precinct. Precinct Delegate races are not canvassed by the Washtenaw Board of Canvassers.

It is critical that the booklet, “Delegates Elected to County Convention” be completed and signed by Election Inspectors at the close of the polls.

All three parties on the August Primary ballot have precinct delegate races.

PRECINCT DELEGATES BOOKLET

Complete blanks:

On front cover and in headings on pages 2 and 3. Print name and registered address of each DELEGATE candidate appearing on the ballot in column 1 for the Republican, Democratic, and Libertarian candidates. Record any valid write-in candidates in the appropriate party’s write-in section.

Number of Delegates to Be Elected:

At the top of each party section in the Delegate booklet record the number to be elected. The number to be elected may differ between the parties and can be found by looking at a sample ballot.

Verify registration:

Find each Delegate’s name on your precinct list. If they are on your list then they are registered and you may mark “yes” in column 3. If not on your list mark “no.”

Record vote totals:

Using a “Totals Report Tape” record total number of votes received by each candidate appearing on the ballot for the office of PRECINCT DELEGATE for each party.

Using a “Write-in Report Tape”, determine the number of votes cast for VALID precinct delegate write-in candidates and record them in the booklet.

- Be sure that the "Certificate of Election Inspectors" on back is completed and signed by all inspectors.
- Place in envelope #1 to County Clerk marked "List of Delegates Elected".

DETERMINE WHO WAS ELECTED based on the “number to be elected” for each party and place a check mark in the appropriate column if a candidate is ELECTED.

Record vote totals:

Using a “Totals Report Tape” record total number of votes received by each candidate appearing on the ballot for the office of PRECINCT DELEGATE for both Republican and Democratic parties.

Determine elected candidates:

DETERMINE WHO WAS ELECTED based on the “number to be elected” for each party and place a check mark in the appropriate column if a candidate is ELECTED. Remember to have carried over any write-in votes from page five to the appropriate party.

Signatures:

COMPLETE and **SIGN** the “Certificate of Election Inspectors” on the back page of the “Delegates Elected to County Convention” booklet. Place the booklet in “Envelope #1 – to County Clerk.”

PRECINCT DELEGATE WRITE-IN CANDIDATES

An individual who wishes to seek a precinct delegate position with write-in votes may file a “Precinct Delegate Write-In Candidate Declaration of Intent” form at his or her precinct on election-day any time prior to the close of the polls.

The filing of this form with the Board of Election Inspectors makes that individual a VALID write-in candidate.

For help with this form, contact your city or township clerk.

Place the completed form in “Envelope #1 – to the County Clerk,” and tally any valid write-in votes found on the “Write-in Report” tape at the close of the polls.

An individual who wishes to seek a precinct delegate position with write-in votes must file this form with the clerk of his or her city or township of residence by 4:00 p.m. on the Friday preceding the August primary. As an alternative, an individual who wishes to seek a precinct delegate position with write-in votes may file this form with his or her board of election inspectors on the day of the August primary any time prior to the close of the polls.
